- \* Campers should notify the Police Department of their plans.
- \* Camping and fire permits must be in possession of campers.
- \* Vehicles must be parked in the parking lot. Campers will need to carry their gear to the campsite.
- \* Youth under 18 must be accompanied by a responsible adult.
- \* No RV's or hookups.
- \* No alcoholic beverages.
- \* Before departure, campers must extinguish fire and remove all gear and trash.
- \* Fires may only be in fire pits.
- \* Trees may not be cut for firewood.
- \* Only fallen wood, or wood brought from off-site may be burned in the fire pit.
- \* Fires may not be left unattended and must be completely extinguished before the fire pit is abandoned.
- \* A permit to have a fire must be obtained from the Milford Fire Department.
- \* Campfires are subject to the Milford Fire Department policy and guidelines.
