    - 3) removal of stumps from the proposed Columbaria Bowl at Seven Pines Memorial Bowl near maintenances building

  - a) Capital Investment Program 2024 2029 begins 29 May 2024 deadline already past

- b) Town Budget Advisory Committee resumes soon
- c) Require budgetary submissions for planning and to develop Warrant Articles for subsequent submission to CIP TBAC and the Board of Selectmen for approval
- d) Develop a program to educate and encourage voters to support and fund the DPW Cemetery Trustees programs to fully develop Riverside Cemetery
- e) Forecast, Plan, Engineer, Budget & Fund improvements at Riverside Cemetery
- 3) Implementation of our various plans via:
  - a) CIP support
  - b) BAC support
