(RSA 91-A:3, II (b)) Personnel – Chairman Daniels said we approved a raise for John but we didn't identify what the percentage would be. Town employees are getting 1.5%. Selectman Dudziak said she wouldn't go any lower, she would give him 2% at least. Selectman Labonte thought 1.5% across the board like everyone else. Selectman Dargie and Selectman Freel suggest 2% at least. Chairman Daniels just wants a consensus on the percentage so he can give the information to Finance. The consensus was 2%.
