Appointment: 7:00pm: Jeffrey Merritt, P.E. presented the Spring Creek Sand and Gravel Plan on behalf of Paul Amato, owner, who was in attendance. Mr. Merritt affirmed the notes on the plan that there are no wetland or buffer impacts. The drainage plan will contain all stormwater within the excavated area. There will be mulch berms to supplement the silt fencing. The reclamation will be to a field in the flatter inner area and revegetated slopes. They have an approved AoT(alteration of terrain) permit and will follow Best Management Practices (BMPs) and other requirements for gravel operations. The commission members have no issues with the proposed plan and will send a letter reflecting this to the Planning Board for their October 15 meeting.
