Appointment: M48L78 Wetland Permit Application for a driveway crossing. Presented by Chris Guida of Fieldstone Land Consultants. The members reviewed a minimum expedited wetland permit application for a driveway crossing accessing M48L78 from Emerson Road. The wetland and buffer are associated with a drainage/intermittent stream that runs through an animal pasture. The low-functioning wetland has been classified as a palustrine ditched meadow wetland; defying easy classification due to the characteristics and uses of the wetland. There will be a 500sq.ft temporary impact and leaves a 500 sq.ft permanent impact with the installation of a 24" culvert. There will be no riprap as DES is less supportive of this construction method. The riprap seems to accelerate scouring of the bottom and banks of the channel. This project is for a single-family driveway crossing of a low-functioning wetland on a relatively flat site. Audrey made a motion which was seconded by Rodney, to approve this wetland permit application. It was unanimously approved. John signed the permit application, enabling an expedited review process at NH DES.

There was a lengthy discussion to determine whether or not this application needs to be reviewed by the Zoning Board of Adjustment (ZBA). There is an estimated 1200sq.ft of buffer impact. The wetlands ordinance leaves room for interpretation as to whether this meets the criteria for ZBA review. CGuida recommended that staff and land use boards meet to determine how this ordinance will be interpreted in future cases.
