Appointment – 7:00 Mr. Farwell presented information regarding his request to impact the wetland buffer on his property, ML56-62-1. The state has advised Mr. Farwell that they would not approve a wetland permit for him to install a culvert in the wetland. He can avoid the wetland by going around the wetland. Due to the surrounding landscape with some steep sections and ledge, Mr. Farwell would like to use part of the wetland buffer for his driveway. After discussion, the members support his request with two conditions that 1) Mr. Farwell does not pave the section of the driveway that is located within the wetland buffer, and 2) he grade the driveway so that stormwater runoff will sheet away from the wetland. Mr. Farwell accepts both of the conditions. He intends to install siltation measures to protect the wetland. Chris will write a memo regarding the MCC decision to the Zoning Board of Adjustment, before whom Mr. Farwell is appearing on July 16.
