Manager Report

- Full time position Numerous candidates applied for the position, Chris is in second round interviews.
- Auditorium upgrade wiring has been installed, equipment install scheduled for next week. On track to be ready for Feb 1st Town Deliberative session.
- Sports coverage Able to cover away wrestling live from Goffstown on Facebook. Jon Teger is covering basketball. Expect to be able to cover Unified Basketball live on Facebook next month.
- Upcoming projects Comcast scheduled mid-March to upgrade PEG uplink equipment to digital and enable HD (high definition) channel. Intent is to use the HD channel primarily for sports but it can be used for any relevant programming. Going digital should improve audio and video quality even on the SD (standard definition) channels).
- Rotary Presentation Chris presented info about GTM to Rotary. Several folks expressed interest in volunteering.

- Tim asked Chris to add signage to podcasts to make it clear it is a podcast and not just audio from a meeting. Currently there is a slide at the beginning of the podcast. Chris indicated he has spoken to Cablecast about this and that we will be the beta site for the new software.
- GTM equipment upgrade at the high school is almost complete except for extending fiber to the athletic field.
