Review of Minutes

No minutes submitted from the last meeting

Appointment of Alternates Two outstanding citizens were sworn into the commission membership by the Board of Selectmen. We are honored to welcome Chris Thompson and Bill Parker as alternates to the Heritage Commission. They will be called to vote when regular members are not present. At this meeting both men were called as Polly Cote and Herb Adams were not able to attend.

### **Old Business**

Tonella Stone Shed The property owners continue to solicit the Planning Board with changes to the building project that will result in the demolition of the historically important Stone Cutting Shed. Several ideas were discussed as how the materials of the stone building can be repurposed for the cause of preserving the story of the stone cutters and the Town's granite heritage. Mark presented a concept of reconstructing the structure in-part for a roofed band-stand at the park on the Fletcher site. Several stone riggers passed on quoting the move and reconstruction of the building. Cost estimates to-date cannot be validated. The group maintains their interest in preserving the structure intact and will entertain concepts for relocation.

Planning Meeting Sit-in Plans submitted to the Planning Board are often modified but not resubmitted for comment from this commission. We understand our role as advisors, but sometimes the changes to the initial plans can have drastic impact. The group discussed the desire to be involved in plans as they evolve. We will make a point of sending a representative to the public Planning Board meetings to stay involved as scope and scale changes occur. Erna expressed her interest in the meeting of Tuesday evening, 26June.

## **New Business**

Town Master Plan There was discussion on how the Heritage Commission can become more relevant. Dave presented the idea of taking on the Heritage Section of the Town Plan to describe what we can do for the service of the town's heritage. Presently the Heritage section of the Master Plan is under the Conservation Commission. We propose to make clear what types of activities that we want to be a part of and even give our opinions on several common topics as listed below.

- The Heritage Commission is interested in a historical review of old structures prior to demolition to offer relevance and alternatives to the owners prior to removal of what may be important historical landmarks. This intent carries over to such minor issues of removing the miles of stone walls that were once more common than today.
- The Commission is interested in providing historical reviews of properties prior to modifications that would cover or remove important architectural features that speak of the town's heritage.
- The Commission is interested in advising residents on the tasteful and lawful factors that go into renovation projects. We can be an assistance to advise owners of older homes on mitigation of lead and asbestos issues.
- The Commission is interested in reviewing properties that have been preserved under Town, State and Federal registries. An example would be to review deeds for heritage restrictions and monitor the compliance.
- The Commission is interested in reviewing new roadway plans for compliance to scenic and archeologically important factors. Examples would include protecting Native American encampments and burial grounds.
- The Commission is interested in contributing to inventories and applications for State and Federal Historical registration. This and other activities will be in partnership with the Milford Historical Society.
- The Commission is interested in advising property owners on Community Revitalization Tax Relief under the guidance of RSA 79-E. We are interested in assisting in the application of grants to preserve barns and relevant properties.
