3. Old Business:

Treasurer job description – E. Olesen said the job description should be something that we want the person to do. J. Wilson said in Mont Vernon, it is a position with the town, the Job Description is whatever we want them to do. E. Olesen said that was the determination to set the hours and rate of pay. J. Johnson asked will it just be checks and balances or actually printing the checks etc? C. Frye and J. Wilson both understood that it would be oversight. J. Johnson asked if it will be an employee or handled on a 1099? J. Wilson said at the end of the day there could be additional hours, but we budget a certain amount, it is just a change from the way it will work. We need to get someone that has done this before that can help J. Johnson and the BOG. E. Olesen asked what will the pay be? J. Johnson said we budgeted \$2500 per year in the past for just the review. J. Wilson said this is for 52 weeks for one hour a week plus the end of year audits plus a learning curve. About 80-100 hours per year. E. Olesen can reach out to the Wilton Treasurer, he spoke with him but did not have enough details, now he can talk to him and get additional information. J. Wilson asked if everyone is comfortable with \$2500 for the year?

- J. Johnson said that is about \$31.25/hour. Are we comfortable with that? That is based on about 80 hours a year. J. Wilson said we can post it for that. We will get that information to J. Johnson this week.
- J. Johnson said the audit draft was reviewed at the last meeting, today we have the final numbers of \$168,857 which has \$55,000 retained from 2020 and \$113,418 to be returned to the towns for surplus. The percentages of the budget are:

Milford \$80,860 \$12,887

MV Wilton \$19,671

- J. Wilson said a questions came up on the return of funds, is there also a need for repair to infrastructure, can the towns agree to put that aback into the repairs? J. Johnson said yes, but that would require the Budget Committee to get together. Using the surplus for anything else requires a public hearing. Mont Vernon needs to get some things taken care of, J. Johnson can confirm with the BOS. E. Olesen would also need to talk to his BOS. If it is beneficial to all the towns, it will not be an issue to use the surplus funds, but he needs to confirm that. C. Frye will also bring that to his BOS in Milford.
- J. Johnson said the surplus funds are supposed to be released by the end of June each year. J. Wilson and C. Frye said their BOSs will meet next week. E. Olesen will talk to the Town Administrator and report back.
