As such, the meeting was conducted in person and on zoom. 18 19 1. Call to order: Chairman Knott called the meeting to order at 6:30 p.m. indicating that tonight is for 20 review of two proposed zoning amendments. D. Knott asked that E. Cohen vote in the absence of S. 21 Robinson. Planning Board members and staff were introduced by D. Knott. 22 23 2. Public Hearing: 24 a. Zoning Amendments. Amend Milford Zoning Ordinance Article VII, Sections 25 26 7.11.3 Definitions, 7.11.4.A Table of Uses and B. Specific Solar System Requirements and Exceptions by adding a requirement for a Conditional Use 27 28 Permit for ground mounted Residential Solar System located in the Residential A, B, R zoning districts that exceed a maximum seven-hundred fifty (750) square feet 29 and regulating the placement of ground mounted units within properties. 30 31 32 J. Cleghorn explained that those corrections were suggested for the definitions which the Board requested be reverted back to what they were previously. This is the first public 33 34 hearing for this amendment. J. Langdell pointed out that tonight's discussion represents 35 only a slice of the ordinance. 36 37 D. Knott opened the meeting to the public, if anyone in the audience or on Zoom would like to add anything to please state your name and your comment. There were no 38 39 comments or questions. The public hearing was closed by D. Knott. J. Langdell moved to bring this in for a second public hearing at the January 18, 2022 Planning Board 40 meeting. E. Cohen seconded. All were in favor. 41 42 43 b. Amend Milford Zoning Ordinance, Article VI, Wetland Conservation District to refer to current and correct references in state laws and regulations, and make 44 changes to Section 6.02.5(B) Accepted Uses-Buffer Zones to identify and expand 45 certain uses that would be allowed within wetland buffer areas. 46 47 48 D. Knott indicated that this zoning amendment has been reviewed previously and there were two corrections requested. J. Cleghorn said there were no changes made after the 49 last review when it was posted and published. These are statutory references according 50 to State and Federal law. J. Langdell noted that these are statutory modifications brought 51 forward by the Milford Conservation Commission. There were no further comments. D. 52 Knott opened the hearing to the public. Hearing no comments from the audience or the 53 visitors on zoom, D. Knott closed the public hearing. J. Langdell moved to bring this in 54
