## **Director's Report:**

- John reviewed the many Events, Trips and Programs the Commission is sponsoring.
- The Daddy Daughter Dance is Feb. 10th, 6-8PM 200 tickets have already been sold.

## Discussion Items

- Ice Rink Maintenance Several volunteers have been caring for the rink which seems to be
  in good shape. There is concern that the weather has been too cold which causes
  maintenance problems. A new mat is to be purchased as the current one sticks to ice. A
  piece of PVC pipe needs replacing. The hockey hours are 6-8 M-Th and 7-10 Sun. The public
  skaters and hockey players need to share ice and/or respect the posted hours.
- Winter Festival Jan. 19, 6-8PM. Rec Commission will supply the fire pits. The chowder is TBD. The shopping and volunteers are all set. There will be hot chocolate, cider, coffee, water and grilled doughnuts. There will be games and races, some on the rink. The Boy Scouts will do a shelter-building demonstration. Arene will inquire as to the possibility of the DPW making a snow hill for sledding.

- MOU The copy of the memorandum with the changes desired by the Rec Commission was not signed by the MCAA. The MOA is tabled until next month's meeting when further discussion will take place.
- Claudia will pursue the Sanford Scholarship. (If won, the scholarship monies would go to benefit our summer program attendees.)
- Kierstyn moved and Liz seconded the motion to approve the December minutes as amended.
- Kierstyn reported that the Milford Dog Park was approved for 501-C3 status. The location is to be determined through discussion with the Rec Commission.
