1. **Opening.**

2. **Approval of Minutes**

- The Committee voted to accept the October 2018 minutes.

3. **Old Business**

- Recycling Barrels in public outdoor places. Jerry spoke with DPW about the use of the barrels.
- Ban on Single Use Plastic Bags. The committee decided to wait for NH legislation to be passed that will enable town to ban bags. Once this is in place, the committee can present the bag ban ordinance to the Milford Selectmen. George will update Kathy Cleveland who inquired about this activity. Celeste and George will stay in touch with legislator Joelle Martin on the status of this.

4. **New Business**

- At the January Meeting there will be an election of officers. Jerry Guthrie expressed willingness to run for Chairman. Celeste is willing to continue as Secretary. George expressed interest in the Vice Chairman position.. Celeste will send a post to the newspaper requesting new committee members.
- Because of the decreased value and market for recyclables, the committee feels that a different name is needed for the committee that encompasses waste minimization and pollution prevention.

Future Issues for Consideration

- Creating an educational Transfer Station “tour” video for posting on the Web and viewing on the cable access channel-George will follow-up with Mike McInerney
- Encourage residents to get a current Transfer Station sticker if they have one that has expired
- From past meeting: larger, more legible signs needed to identify locations for recycling:
 1. Ni-cad and lithium batteries
 2. Cell phones & chargers
 3. Computer cartridges,
 4. Fluorescent bulbs
 5. Eyeglasses
 6. Thermometers
 7. Fluorescent light ballasts

Tammy suggested the signs match other signage at the Transfer Station, being dark green metal with white lettering. Celeste will get some rough estimates for possible inclusion in the next budget. The signs should be large enough for people see from the mixed paper side of the building.
