1. **Opening.**

The meeting was opened at 6:33 p.m. by Vice Chair Jerry Guthrie.

3. **Old Business**

**Pumpkin Festival.**

The Committee was disappointed in the placement of the Recyclemobile. It received very little visibility and use during Festival. Middle Street is too crowded to be able to see to the end where it was located. The west side of the Oval would have been better for people to pass by.

**Signage at Transfer Station**

The group brought up the idea of better collection vessels and bigger more professional and signs to identify recycling of ni-cad & lithium batteries, fluorescent bulbs, cell phones and chargers, eyeglasses, computer cartridges, thermometers and fluorescent light ballasts.. The signs should be visible from a distance so people can see them from their cars or from the Mixed Paper collection area. Tammy said Dark green signs with white lettering would conform with existing signs. Celeste will check with Classic Signs on estimated cost for metal printed signs. This could go into the 2019 budget potentially.

Municipal Ban of single use Plastic Bags- To be discussed next meeting.

Diane invited the Committee to attend the 2018 Trash on the Lawn Day on Oct 26 at Milford Middle School. TOLD is a waste audit in which students sort and weigh all trash, recyclables and compostables. It is facilitated by the Northeast Resource Recovery Association as an educational activity.
