RE: Sate of NH – Opioid Settlement Participation Agreement



The New Hampshire Department of Justice has negotiated separate settlements with five companies related to their opioid conduct. Three of the companies are major pharmacy chains (CVS, Walgreens and Walmart) and two of them are opioid manufacturers (Teva and Allergan). The settlements, in total, will bring approximately \$100 million dollars into New Hampshire to help fight the opioid crisis. All of the money received by New Hampshire will be used for opioid abatement projects. Milford has been identified as a jurisdiction that is eligible to apply to the Opioid Abatement Commission for a share of these funds.

As in past settlements (e.g. most recently Johnson & Johnson in 2022), Milford has been identified as one of those subdivisions (cities or towns with a population of at least 10,000) from which the defendants want participation agreements. In essence, these defendants want some assurance that this settlement will end their exposure for their opioid conduct and that Milford will not bring an opioid-related lawsuit against them in the future. The State has asked the Town review the material, and that Select Board sign the participation agreements for all five settlements. Forms for each settlement are attached below. Discussion:

Staff and Town Counsel reviewed the information and participation agreements and have no issues with the Select Board executing said agreements. By executing the participation agreements, the Town will have the opportunity to receive funding for local opioid abatement projects and programs to assist those individuals in need.

Recommendation:

Staff recommends that the Select Board vote to execute the five participation agreements and allow Milford the opportunity to be eligible for the settlement funds.
