The applicant is before the Board of Adjustment seeking a VARIANCE from the Milford Zoning Ordinance, Article V, Section 5.02.4. to subdivide the subject lot and create a separate 1.3 acre lot with 60 feet of linear frontage on Federal Hill Road where 150 feet is required for a parcel in the Residential 'A' district not serviced by municipal water and wastewater.
