



A PROCLAMATION

TO RECOGNIZE

TWENTY YEARS SINCE SEPTEMBER 11, 2001

WHEREAS, on September 11, 2001, terrorists hijacked four commercial airplanes, flying two of them into the twin towers of the World Trade Center in New York, causing both buildings to collapse, and flying a third one flying into the Pentagon in Washington, inflicting severe damage, while the fourth hijacked plane crashed into a field in Shanksville, Pennsylvania, when passengers who became aware of the attacks attempted to take the plane back; and

WHEREAS, every year since, we come together in solidarity as a nation to remember the first responders and civilians whose lives were cut short by these acts of terror some 20 years ago; and

WHEREAS, that day and the days that followed, our Country was united, Americans of all races, backgrounds and religions uniting in prayer, with a resolve to help the families of victims and first responders who were never given the opportunity to live out their full lives; and

WHEREAS, on September 11th, we pay tribute to the first responders and citizens who, without hesitation, answered the call to save lives with tremendous acts of courage, and on this day, and each and every day, we must strive to stand united, doing so with understanding, love and respect for one another; and

WHEREAS, it is our sacred duty to never forget the events that transpired on that painful day in our country's history so that future generations can be reminded that we are stronger as a country when Americans from all walks of life unite together; and

WHEREAS, we will never forget the military men and women who have answered the call to defend our freedom since this attack on America,

THEREFORE, be it proclaimed by the Town of Milford, Board of Selectmen, Milford NH, that, in solidarity, we honor the lives lost, directly and indirectly, when our country was attacked 20 years ago and resolve that September 11th will be recognized as a "Day of Solidarity and Remembrance".
