- a. The Art of Learning Child Development Program/Kailey Bento Minor Site Plan Application for a change of use to convert a portion of the single-family residence and outdoor area into a daycare operation serving a maximum of 12 children. The parcel is located at 100 Elm Street, Tax Map 20, Lot 51 in the Commercial 'C' Zoning District.
- b. In accordance with the requirements of NH RSA 675:3, the Milford Planning Board will hold a Public Hearing on Tuesday, January 5, 2021 and January 19, 2021 beginning at 6:30pm via Zoom. The purpose of the public hearings is to discuss the proposed amendments to the Town of Milford Zoning Ordinance as follows:
 - Amend Article V, Sections 5.02.5 Yard Requirements, 5.03.6 Yard Requirements, and 5.04.5 Yard Requirements by deleting Subsection C in each relative to accessory structures in the Residential A, B, and R Zoning Districts.
 - Amend Article VII, Supplementary Standards by inserting new Section 7.15 Mobile Food Vendors to regulate and accommodate mobile food vendors in appropriate locations
