# **Discussion**:

Janet expressed concerns that the O'Connor Funds were getting tight and Deno suggested changing the objective from 60/40 to 50/50 to generate more income. Tina made a motion to change the objective and Joan seconded. Deno is authorized to invest all but 50K.

Deno asked if we had time to go through the Investment Policy, (IPS) and Janet said that she was working on it. Deno gave some suggestions to help. The Trustees will have Citizens back to review the results of the changes in March 2018.

Janet suggests that the Trustees review and make changes to the IPS at the December 6, 2017 meeting. Joan has concerns about space for Trustees information. Also at December's meeting, the Trustees will review what can be purged and what needs to stay. Tina will work on the purging in December to make additional space for future reports.
